FIVE PROGRAMS WITH BIG IMPACT

Community Gifts*: Serves the communities where we operate around the globe. Most community gift awards are between \$10,000 - \$15,000 per organization.

- Applications are reviewed annually and must be submitted online between November 1 and January 31.

Impact Gifts: Supports longer-term, multi-year initiatives at a larger gift amount. The foundation is not considering any new opportunities until 2029.

Associate Gift Match: Matches associate contributions to eligible and verified 501c3 organizations as approved through YourCause. This platform provides a centralized location for associates to contribute to charitable causes.

Dependent Scholarships: We offer a scholarship program for dependent children of full-time Milliken & Company associates, which can be renewed annually for up to three years.

Disaster Relief / Emergency Funds: We budget funds to support unplanned disasters or other situations that our associates care about or that happen near our locations.




