## Assembly System: DIRECT STICK (Details Below).

The floor covering was directly stuck to the substrate using Water Based Surface Contact adhesive.

Substrate: Non-Combustible - 6mm Fibre Reinforced Cement Board to simulate a Non-Combustible Flooring. The Holding Torque on Specimen Frame was 2Nm.

The standard requires two Initial Tests be conducted on samples mounted in both Length and Width directions. Two further samples are then tested in whichever direction has the lowest Critical Radiant Flux.

The values quoted below are as required by BCA and NCC Specification C1.10 Fire Hazard Properties (Floors). The Critical Radiant Flux quoted is the value at Flame-Out/Extinguishment (BCA General Provisions A1.1).

## Mean Critical Radiant Flux 4.1 kW/m<sup>2</sup> Mean Smoke Development Rate 67 %.min

Observations: The samples shrunk away from the heat source, ignited and burnt a relatively short distance.
